## **Dance/Prom Policy**

### **Whitinsville Christian High School**

- 1) The faculty advisor for the Student Council must approve all dance sites. In addition, the advisor must approve all decorations at the site where the dance is held.
- 2) Dance music must be approved by the High School principal and the Student Council advisor in advance.
- 3) If anyone is absent from school during the day of a dance (other than an absence approved by the administration), he/she may not attend the dance in the evening.
- 4) The dress code is the same as that for school unless otherwise noted. This includes guests.
- 5) A school dance is not public. Only students enrolled in the Whitinsville Christian School may attend dances sponsored by any school-related group. School dances are intended for current High School students only, WCHS students are allowed to invite one non-WCHS guest. Invited guests, who are not WCHS students, must be registered (fill out attached permission form) in the office or with the class advisor before the dance. Only students in grades 9 or above are allowed to attend. Guests must supply the chaperones with school ID's.
- 6) Eighth grade students are NOT permitted to attend high school dances/proms.
- 7) Students will not be allowed entrance into the dance after the first hour, unless prior permission has been granted.
- 8) If anyone leaves the building at any time without permission of the person in charge, he/she must leave the premises and will not be allowed to return.
- 9) No food or beverages may be taken into the dance.
- 10) Band or D.J. selection must receive prior approval of an administrator.
- 11) There will be no slam-dancing, moshing, grinding, or other dancing that could be considered by the chaperones as having the potential to cause an injury or be sexually provocative. Students who do not cooperate with this rule will be sent home, their parents will be called, and they will not be permitted to attend any other school dances.
- 12) Students, who attend a school-sponsored dance/prom, will not engage in inappropriate physical contact or public displays of affection.
- 13) Consumption of alcohol or drugs prior to attending a school activity or on school property is a violation of Massachusetts State Law. The parents of any student violating this rule will be notified immediately. Other consequences will follow in accordance with rules and regulations outlined in the parent/ student handbook.

NOTE: WCHS administrators reserve the right to make the final decision as to whether or not any WCHS students and/or guest has permission to attend the dance/prom.
